Additional Shipping Line USA / NZ Trade lane notifications of note:

A number of carriers, including **CMA CGM, Hapag, ANL & Maersk** have advised that the **trucking market in the United States** continues to face challenges due to a capacity shortage. As a result, some of these carriers have started to announce **Emergency Intermodal Surcharges** or **increases in their inland tariff** to cover the additional costs of contracting trucking services. These surcharges and increases vary in value and date of application depending on the shipping line and location of the freight, so please contact your local customer service representative for more details.

CMA CGM have announced that they will **cease offering their PAD 2 service** from the **East Coast of the USA** to Australia & New Zealand effective from the **17th of March**. They will, however, continue to offer their PAD 1 weekly service on this tradelane.

Shipping Line Surcharges & Fees – 27 February 2018:

OOCL have advised that they will increase their **Terminal Handling Charges** on all **import and export** containers effective from the **7th of March**. The increases vary depending on container type and shipment direction, please check with your local Mainfreight Air & Ocean customer services representative for more information.
