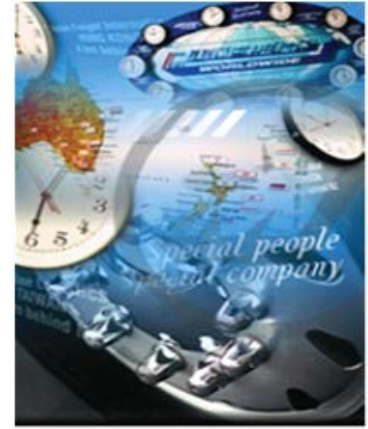

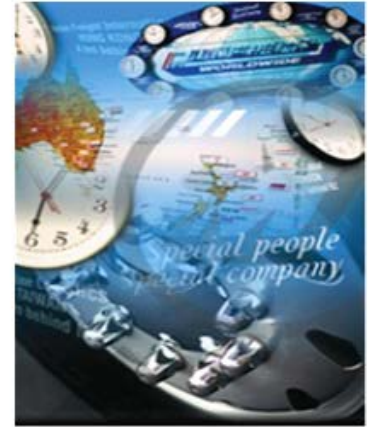

Additional Shipping Line SE Asia / NZ Trade lane notifications of note:

Hapag Lloyd is currently reviewing their **Asia – New Zealand** products, and has advised that their current **New Zealand Loop A-1** and **Loop A-2** services (**NZA** and **NZC**) will operate until the **end of the year**. Their new product will be unveiled in the near future.

A number of shipping lines (including **MOL**, **Hamburg Sud**, **PIL**, **OOCL**, **MSC**, **Cosco** & **APL**) have advised their intention to implement another **General Rate Increase (GRI)** effective from the **15th of November** from **Asia to New Zealand**. The increase, if applied, has been announced at between **US\$50-200 per TEU**, although may be applied at different levels depending on the load port and shipping line. Please contact your local customer service representative for more details.

Shipping Line Surcharges & Fees

Mainfreight Transport have advised that as of **Monday the 6th of November**, the **Fuel Adjustment Factor** will increase by 0.80 percentage points. This increase takes the price into the 125 – 130 cents per litre category. For the majority of their customers, the new Fuel Adjustment Factor will be **0.80%**.
